

## Corporate Social Responsibility and Sustainability - Strategy and Plan

#### Introduction

The term Corporate Social Responsibility (CSR) is a concept whereby organisations consider the interests of society by taking responsibility for the impact of their activities on stakeholders (customers, suppliers, employees, shareholders, communities, and government) as well as the environment.

This accountability is seen to extend beyond the statutory obligation to comply with legislation and sees organisations voluntarily taking further steps to positive responsibility. Respect for, and implementation of, CSR goals contributes lasting value.

This policy sets out Connect2Charity's approach in respect of CSR.

As a registered charity with defined objects, Connect2Charity's social responsibility is fulfilled largely through altruistic services provided to Isle of Man charities\*.
